Notice of Intended Disposition

1. Notice is here given in accordance with the Native American Graves Protection and Repatri-ation Act (NAGPRA), 43 CFR 10.6 (c), of the intent to transfer custody of Native American Hu-man Remains in the control of the USDA Forest Service, Cleveland National Forest, A detailed assessment of the human remains was made by Cleveland National Forest officials in consulta-tion with representatives of Campo Band of Mission Indians.

2. On July 13th-17th, 2017, human remains were removed from Cameron Valley Cremation Site in San Diego, CA. The cremated remains were in-advertently discovered as a result of trenching for utility line replacement on Forest System Lands A small number of bone fragments were removed from the back dirt on July 13th for identification by the San Diego County Coroner. Addi-tional bone fragment remains were exposed in the back dirt on Monday, July 17th, and were in-spected, in the field, by faunal specialist and a forensic anthropologist, who positively identified the presence of fragmented human remains. Burnt soil and bone fragments were subsequently gathered into bags and removed to preserve the soil matrix and prevent further exposure and damage as consultation with local Native American Tribes was initiated. No known individuals were identified.

Officials of the Cleveland National Forest have determined that, pursuant to 43 CFR 10.2 (d)(1), the human remains described above represent the physical remains of at least one individual of Native American ancestry.

4. Lastly, officials of the Cleveland National Forest have determined that, pursuant to 43 CFR 10.6 (a)(2)(ii):

• A relationship of shared group identity can be reasonably traced between the human remains and the Kumeyaay Indians, of which the Campo Band of Mission Indians has offered to take the lead on behalf of the twelve Kumeyaay Tribes represented by the Kumeyaay Cultural Repatriation Committee.

Representatives of any other Indian tribe or Native Hawaiian organization that wishes to claim ownership or control of the human remains should contact William Metz, Cleveland National Forest, 10845 Rancho Bernardo Drive, Suite 200. San Diego, CA 92127, telephone (858) 674-8180, before September 22nd, 2018. Disposition of the human remains to the Campo Band of Mis sion Indians may proceed after that date if no ad-ditional claimants come forward.
