The work generally includes furnishing all labor, materials, equipment and services to:

Construction of approximately 972 linear feet of 8-inch PVC C900 water pipeline and appurtenances. Removal and replacement of asphalt along installed facilities. Removal of approximately 1,015 linear feet of 3" water highline (including some areas where highline is buried) and appurtenances.
