**PLANTING IN THE TEMPLE: APRIL SHOWERS,
MAY FLOWERS**

In the Agni Yoga Wisdom teachings, there are references to the light from stars, planets, moon and sun vitalizing trees and flowers to be used by humanity as foods, resins, oils and medicines. All these substances are life givers and thus planted in temple gardens. The flowers most mentioned are roses, freesias and lilac and trees of pine, cedar and eucalyptus.
