**Passover, Full Moon,
Resurrection
& Easter Festivals**

This coming weekend is filled with festivals, spanning three levels of humanity's development. We have the Jewish festival of Passover (beginning Friday at sunset); the Aries Festival, Festival of Love (esoteric teachings for the new Aquarian era) Saturday; and Easter (Catholic/Christian festival) on Sunday. Passover represents the Age of Aries; Easter, the Pisces Age; and the Aries Festival at the full moon signifies the Aquarian era. Each Age spans 2,500 years.
