

The Draft Environmental Impact Report (DEIR) (SCH # 2021030196) for the Alpine Park Project (project) is now available for review. Public comment on this document is invited for a 60-day period from December 16, 2022 through February 14, 2023. More information is provided below.

Project Title: Alpine Park Project (SCH No. 2021030196)

Lead Agency: County of San Diego, Department of Parks and Recreation

Project Location: The project is in the eastern portion of San Diego County, California, approximately 1 mile south of the center of the unincorporated community of Alpine, and approximately 1 mile south of Interstate (I-) 8. The project is adjacent to the Backcountry Land Trust's (BCLT) Wright's Field Preserve, to the north of South Grade Road and east of Tavern Road, south of Alpine Boulevard.

Project Description: The proposed project would involve the development of an approximately 25-acre active park that would include potential multi-use turf areas, baseball field, all-wheel area, bike skills area, recreational courts, fitness stations, leash-free dog area, restroom facilities, administrative facility/ranger station, equestrian staging with corral, nature play area, community garden, volunteer pad, pienic areas with shade structures, pienic tables, game table plaza, and trails. The remaining approximately 70 acres would be open space/preserve that would allow for restoration/habitat enhancement.

Purpose of The Recirculated Sections of Draft EIR: The Recirculated Sections of the Draft EIR is part of the ongoing environmental review process for the Project and has been peraerd to address public comments, clarify and expand upon the analysis in the Draft EIR, and reflect the updated regulatory context. CEQA requires recirculation of an EIR when the lead agency adds "significant new information" to an EIR regarding changes to the project description or the environmental setting after public notice is given of the availability of a draft EIR for public review (State CEQA Guidelines Section 15087) but before EIR certification (State CEQA Guidelines Section 15088.5[a]). Recirculation is not required unless the EIR is changed in a way that would deprive the public of the opportunity to comment on significant new information, including a new significant impact for which no feasible mitigation is available to fully mitigate the impact (thus resulting in a significant and unavoidable impact), a substantial increase in the severity of a disclosed environmental impact, or development of a new feasible alternative or mitigation measures that would clearly lessen environmental impacts but that the project proponent declines to adopt (State CEQA Guidelines Section 15088.5[a]). Recirculation is not required when the new information added to the EIR merely clarifies or amplifies or makes insignificant modifications in an adequate EIR (State CEQA Guidelines Section 15088.5[b]).

Availability: In response to the continuing COVID-19 pandemic, Governor Gavin Newsom on September 23, 2020, issued Executive Order N-80-20 and N-8-21, which extends the suspension of certain filing, posting, noticing, and public access requirements for projects under review pursuant to CEQA. Suspension of these filing, posting, noticing, and public access requirements is conditioned upon the lead agency, responsible agency, or project applicant taking the following actions:

- · Posting the otherwise-required notices to the relevant agencies or applicant's public-facing website for the same period ordinarily required of physical posting in the county clerk's office. Please see the Draft EIRat: www.sdparks.org/publicreview
- · Submitting all such notices electronically to the State Clearinghouse; and
- Engaging in outreach to any individuals and entities known by the lead agency, responsible agency, or project applicant to be parties interested in the project in the manner otherwise contemplated by applicable provisions of CEQA and the CEQA Guidelines.


