Obituary



Ruth Jellison, long time resident of Alpine, peacefully died on October 4th, 2023, at the age of 94. Ruth and her husband Don Jellison settled into their home on Old Palo Verde Ranch when the family moved to Alpine, California in 1969 with their five children Monica, Neal, Eric, Margaret (Megan), and Kurt ranging in age from 6-12 years of age. Throughout this time, Ruth excelled in creating a beautiful, loving, and gracious home for her family.

In her children's younger years during the 1970's Ruth could be seen around Alpine on the little league fields selling team snacks from the back of her station wagon, sewing costumes for the Alpine Elementary Schools spring productions, walking out of the Alpine library with her arms full of books for her children's studies (as well as one for herself), pulling into Queen of Angels parking lot every Sunday and rushing into mass with all 5 children in tow, and standing at the kitchen window in her sunglasses (so she wouldn't wake up too completely) shouting out how close the morning bus was from our bus stop so those of us that were stragglers could start running. Raising five young children through those school years kept her busy, pleasantly exhausted, and Alpine buzzing! Ruth convinced Don's brother Bob Jellison and his wife Gale and their young family to move to Alpine a few years later saying it was the perfect place for her and Don to raise their children: which later all five of Ruth's adult children would agree.

In 1978 as the children grew and the older ones started to leave the nest, Ruth's husband Don sadly died of lung cancer.

Being widowed at the age of 48 left an empty space for Ruth to fill so she returned to the work force as her youngest two children finished high school. Upon returning altar boy vestments to Queen of Angels Catholic Church in Alpine after Don's funeral, Ruth ran into the new Pastor Father MacLaughlin his first week at the parish. They met, talked and she was ready to work again in a clerical role, and Ruth became the church secretary, a role she enjoyed for 12 years. During this time Ruth took an active role in many community organizations in Alpine. Ruth was a member of the Alpine Women's Club, the Soroptimist Club, the Alpine Historical Society, Queen of Angels organizations and various areas she could lend her talent and time. Ruth expanded her work experience to include the Alpine Man and Woman Clothing Store when the Alpine Creek Shopping Center was built and later worked at the Alpine Chamber of Commerce in the center of town. Ruth and Don supported Alpine business whenever they could from weekend runs to Al Hinkle Hardware to picking up donuts at the Alpine Bakery for church fellowship each Sunday. Ruth's interest in the community and growth of the town was always forefront and after Don's passing even included a business venture with Dave Carlin Equipment Rental.

Whether it be participating, organizing, or just enjoying one of Alpine Community's many social events, such as the annual parade down Alpine boulevard or the Concerts in the Park, Ruth's gregarious smile and agreeable company would be known and enjoyed by many. Ruth's greatest pastime in her later years was finding a grandchild or great grandchild to

go for a Sunday drive after Mass and visit all the sights of Alpine while stopping by to visit her varied and many friends. Ruth always considered the little town of Alpine her home and has touched many hearts in a big way since she first arrived in 1969.

Ruth legacy of Love, Labor, and Loyalty leaves behind 13 grandchildren Nicole and Brad, children of Monica and Dave Carlin; Raquel and Sonya, daughters of Neal and Elisabeth Jellison; Matt and Morgan, sons of Eric (deceased) and Kimberly Jellison; Katie, Erika, Jonathan, Justin, and Margaret Emily, (Meggie) children of Allan (deceased) and Megan Breesee; Donald and Dean, sons of Kristy and Kurt Jellison. Ruth's love expanded as the great grandmother to 15 great-grandchildren and never tired of having a little one climb up into her lap, or a young teen giving her a hug or telling them a story about Alpine.

Funeral Services will be held on Thursday October 26, 2023, at Queen of Angels Catholic Church in Alpine with the Rosary at 10:30 and the Mass at 11:00. Burial will be at Alpine Cemetery immediately following the funeral service.
